This event is licensed by the Amateur Athletic Union of the U. S., Inc. All participants must have a current AAU membership. AAU membership may not be included as part of the entry fee to the event. AAU membership must be obtained before the competition begins except where the event operator has a laptop available with an internet connection. BE PREPARED: Adult and Non-Athlete memberships are no longer instant and cannot be applied for at the event. Please allow up to 10 days for membership to be processed. Participants are encouraged to visit the AAU web site www.ausports.org to obtain their membership.

Dancing with the Family! Rules

- 1) Dancer and member of the family being taught a routine, must both be AAU Members. Dancers can obtain an AAU MEMBERSHIP at aausports.org
- 2) Dancer teaches sibling or parent a routine in Ballroom, Latin, Hip Hop, Folk, Contemporary or any other dance genre.
- 3) Length of routine must be between 45 seconds and 1.5 minutes long.
- 4) Costumes are encouraged but practice outfits are allowable. Attire that is inappropriate or revealing will result in disqualification of entry.
- 5) Entries must be in MP4 format.
- 6) Submit Entries to the Google Drive by November 30th. Instructions for submitting this entry will be sent via email once registration and payment is complete.
- 7) Instructions for viewing Virtual Performance will be sent after Registration has been confirmed.
- 8) Family will be judged on their style, swag, dancer's approachability to family member in their choreography, the togetherness of the two people, and the overall performance.
- 9) Entries are \$20 per entry.
- 10) Finalists from each state will be announced via email and on the AAU Dance Website on December 14th as well as the information of the Finalist 4 state competition.
- 11) Finalists chosen by the judges will be entered into a virtual Multi-State competition with Idaho, Nevada, and California.
- 12) State Winners will also receive an AAU Dance Tshirt!
- 13) Virtual 4 State Performance will take place via the internet December 14th.
