**Sanction:**

- This event is licensed by the Amateur Athletic Union of the U. S., Inc.
- All participants must have a current AAU membership.
- AAU membership may not be included as part of the entry fee to the event.
- AAU membership must be obtained before the competition begins except where the event operator has a laptop available with an internet connection. Participants are encouraged to visit the AAU web site [www.aausports.org](http://www.aausports.org) to obtain their membership

**Be Prepared:** Adult and Non-Athlete memberships are no longer instant and cannot be applied for at an event. Due to background screenings, please allow up to 10 days for adult memberships to be processed.

**Sanction Number: applied for**

**Facility:** Five Lane 25 yard indoor course with non-turbulent lane lines, SR Smith Starting Blocks. Colorado Electronic Timing System with touch pads and horn start. One Line LED Colorado Scoreboard. .

**Meet Type:** Age group events, timed finals. Male and Female swimmers will be combined but scored separately.

**Seeding:** Please submit the swimmers best short course yards times to ensure proper seeding.

**Entry Limits:** Swimmers may enter a maximum of five (5) Individual events.

**Entry Fees:** \$25 Fee per Swimmer – Includes all facility fees, individual events, heat sheet

**Entry Deadline:** Entries must be received by Saturday, Sept 5th. The preferred method of entry is by Hy-Tek digital files accompanied by emailed or hard copy entry summary sheet. Email entries to [coachceprice@gmail.com](mailto:coachceprice@gmail.com)

**Deck Entries:** Deck entries will be accepted by the Clerk of Course until 8:45 am. A swimmer who is not previously entered in the meet must pay \$25 plus deck fee of \$15. Deck entries for each event will be placed in open lanes in existing heats in the order in which they are received by the Clerk of Course. No event will be reseeded to accommodate a deck entry.

**Scratches:** No money will be refunded for scratches.

**Warm-Up:** Warm-up lanes and times will be assigned. Any swimmer who does not enter the pool feet first during any portion of a warm-up/warm-down period which requires feet first entry shall receive a warning for the first offense rather than a disqualification. Disqualifications are automatic for subsequent violations. In the session in which the penalty is enforced, the swimmer cannot deck enter an event to replace the event from which they were removed.

**Awards:** Ribbons will be awarded 1st-5th place in 8and under (25s and 100 IM) 10 and Under, 11-12.
