Traditional Solid White Gi, no rolled sleeves or cuffs, pants must be at least 2/3 length between ankle and knee), sleeves must be at least ½ length (between wrist and elbow), females must wear plain white T-shirt or white sport bra under top and no headbands or jewelry.

OFFICIAL'S DRESS CODE

Navy blue blazer, White shirt, Official USA Karate tie, plain light gray trousers, dark or black socks, and black shoes. Jewelry of any kind is not allowed.

COACHES' DRESS CODE

Coaches must wear a Polo shirt, white gi pants, white socks and sneakers, and display official identification.
