 - AAU membership may not be included as part of the entry fee to the event.
 - AAU Youth Athlete membership must be obtained before the competition begins. Participants are encouraged to visit the AAU website @ <https://aausports.org/Join-AAU> to obtain their membership. You may register without a team – annual youth membership is \$20 and coach membership is \$55.
 - Adult and Non-Athlete memberships are no longer instant and cannot be applied for at an event. Due to background screenings, please allow up to 10 days for adult memberships to be processed.

- Facility:** Outdoor 8 lanes 25-yard pool. Water depth at the starting end is a minimum of 5'8" at both ends. Non-turbulent lane lines. The Colorado timing system will be used with an 8-lane scoreboard. Warm up/cool down lanes available.
- Meet Type:** Age group and senior events, timed finals.
- Seeding:** Short course times will be used for seeding purposes.
- Entry Limits:** Swimmers may enter a maximum of 6 individual events and 2 relays. Athlete's age on the day of competition shall determine the age division of the swimmer.
- Fees:** \$25 Entry Fee (A portion of the proceeds will go to the Coach Bill Bolton Scholarship Fund to provide free or reduced rate swim classes to those in need.)

Warm-Ups: Swimmers must enter the pool feet first except during the designated sprint warm-up using the blocks.

Scratches: Money will not be refunded for scratches.

Awards: In individual and relay events, medals will be awarded for 1st through 3rd places. Ribbons will be awarded for 4th through 8th places. High point awards will be given for girls and boys in the following age groups: 8&U, 9-10, 11-12, 13-14, 15-18.

Scoring: Individual Events: 9-7-6-5-4-3-2-1
Relays: 18-14-12-10-8-6-4-2.
Events will score as follows: 8 and Under; 9-10, 11-12, 13-14, 15-18
