MUST PROVIDE BIRTH CERTIFICATE AND PROOF OF SCHOOL GRADE ENROLLMENT

*There is no weight allowance. **Weigh in uniform is singlet, no socks or shoes.** You will not be allowed to strip down to underclothes and you will not be allowed to leave the weigh in room to run. If you do not make weight you will be scratched or **pay \$20 re-bracket fee.** There will be no refunds.*

2 nd ,3 rd	Not 10 before 8/31/18	40,45,50,55,60,65,70,75, 80, 90,100,110, HWT (125 Max)
4 th -5 th	Not 12 before 8/31/18	50,55,60,65,70,75,80,85,90,95,100,108,118,128,140,155,HWT (175 Max)
6 th	Not 13 before 8/31/18	60,65,70,75,80,85,90,95,100,105,110,115,120,125,130,135,140,145,152,160,171,189, HWT (250 Max)
7 th -8 th	Not 15 before 8/31/18	70,75,80,85,90,95,100,105,110,115,120,125,130,135,140,145,152,160,171,189,HWT (250 Max)

No 9th graders. If your age exceeds the limit for your division then you must move up a division. You may not move down a division even if your age is within the age requirement. 6th graders may enter the 7th-8th grade division if so desired. ** Tournament director reserves the right to combine/alter weight classes.
