COVID-19 POLICIES

- 1) **We will max at 400 athletes.**
- 2) **Number of spectators per gymnast: 3**
- 3) **Spectator Seating: spectators will be required to bring their own seats, or rent one from us**
- 4) **Alternative spectator viewing options: we are looking into possible livefeed**
- 5) **Mask requirements: assuming that it is still the state guidance, we will require everyone that enters our facility to wear a mask. Gymnasts will be required to wear a mask while rotating between events, but may warmup and compete without it on, but may still wear it if they believe they can do so safely.**
- 6) **Covid-19 check in procedures & waiver: we will require everyone that enters the building to sign a general covid waiver, be subject to temperature scan, hand sanitise, and adhere to our mask mandate if it is still a recommendation.**
- 7) **Cleaning Protocol: We will be cleaning high touch surfaces throughout the day, light cleaning between rotations, as well as a deep cleaning between days.**
- 8) **Meet Format: will be a version of modified traditional although we will compete out of order so that we can have maintain social distancing.**
- 9) **Judges: as per NC AAU Rules**
- 10) **Refunds: provided for any reason ONLY when submitted through Meetmaker.**
 - 75% refund (8+ days from start of event)
 - 50% refund (0-7 days from start of event)
 - *Meetmaker processing fees are non-refundable.
